What's New For 1099s

What's New For 1099s

- Electronic filing required for any employer identification number (EIN) with more than ten 1099s (aggregate of almost all return types 1099, W2, etc.)
 - Used to be 250
- No changes to 1099-NEC form for 2023
- New online portal (IRIS) for filing 2022 and later (no more FIRE)
- Check with your state to see if they participate in combined federal/state filing

Tips!

- Use a service to mail, email and file 1099s
 - Services like Aatrix will do all three for about the cost (or less) than it would take to manually print, mail and file your 1099s
- Use Excel/Power BI to review and upload 1099 information

Automate Allocations, Consolidations and Eliminations

- Use unit/statistical accounts to track items, such as head counts and square footage, that can be used to allocate expenses
- Setup templates for monthly allocation and elimination entries
- Configure accounts and companies/subsidiaries for automated elimination
- Use tools, such as Vena and Solver, for consolidated reporting
